Hi Everyone,

Throughout tax season we talk a lot about the **Disability Tax Credit (DTC)**, and how it can help you to access tax savings, Registered Disability Savings Plans, and more.

The disability tax credit or DTC is a non-refundable tax credit intended to financially help people with disabilities. It is also designed to help supporters, such as parents, reduce the amount of income tax that they pay.

This year we have received reports about an increased number of advertisements, mostly on Facebook, for businesses indicating that they will help you apply for the Disability Tax Credit.

**Please be aware that using one of these businesses could cost you up to 25% of the money that you will get from your Disability Tax Credit, costing you hundreds or even thousands of dollars.**

There are other, **free** options (please note: your doctor may need to charge you a fee to complete some paperwork required for application). Please contact [rachel.janzen@c-a-s-s.org](mailto:rachel.janzen@c-a-s-s.org) if you want more information about **free** ways to apply for the Disability Tax Credit (excluding the cost of the paperwork required from your doctor), or if you have already used one of these services to apply for the DTC and want to stop them from being able to charge you in future tax years.

In our efforts to provide education around the DTC, we will be hosting an **information session** delivered by the **Canada Revenue Agency Outreach on Wednesday May 8th from 1-2:30 pm**. We invite all CASS clients, staff, and other supports to attend to **learn more about this valuable tax credit, and how to combat misinformation around the application process.**
